RULES & REGULATIONS

1. Introduction

AI WRITERS BOOTCAMP – hereby referred to as “the program” or “the workshop” – is a program initiated and organized by SERIES MANIA (Association du Festival international des séries de Lille / Hauts-de-France).

AI WRITERS BOOTCAMP is one of the programs carried out by SERIES MANIA INSTITUTE. SERIES MANIA INSTITUTE is an initiative created by SERIES MANIA to **train series professionals**, with three main objectives:

- Sharing European expertise to create a network of cooperation between professionals
- Decentralizing the TV series industry to fluidify the creative process and respond to increasing production volumes
- Opening up the sector to diverse backgrounds and origins to enable all talent to access TV and creative professions

AI WRITERS BOOTCAMP is **an online 3-day training program** targeting **creatives and creators, such as screenwriters, agents, development executives and story editors...**

The focus of this three-day training program is about understanding the impact of generative AI on the entire audiovisual chain, as well as mastering the art of the prompt and chatbots to add AI to your creative toolbox.

Objectives: Master AI integration in the creative process
Develop Practical AI Skills
Navigate AI Legal and Ethical Considerations

Method: Hands-on workshops
Interactive sessions
Masterclass with AI experts

Format

Dates: November 25-27, 2024 - three full consecutive days, between 9.30am – 5.30pm (21 hours)

Location: **Entirely online on Zoom**

Number of participants : up to 24 participants

2. Schedule

The timeframe of the program will be structured as follows:

September 3 - November 11, 2024: Registration

Monday, November 25 to Wednesday, November 27, 2024: AI WRITERS BOOTCAMP program

All participants must be available from the beginning until the end of the program, to attend remotely via an online videoconference link provided prior to the Training.



3. Language

The common working language of the program is English: this means that all written and spoken materials, at all steps of the process, must be in English.

4. Registration

Registration must be done in accordance with the rules below and within the specified dates above.

Registration is **free of charge**. To register, fill in the **online registration form** below. It is necessary to provide a copy of the identity card or passport. Submissions by e-mail, post or any other means will not be accepted.

Following the submission of the registration form, each participant will be contacted by Series Mania Institute within the following 15 days, in order to validate their participation.

Before finalizing the registration, it is necessary to read and accept these Rules and Regulations. Confirmation of the registration therefore implies acceptance of these Rules and Regulations. No modification, addition or deletion can be accepted.

5. Tuition fees

The tuition fee of the program is **€1,800 (including taxes) per participant**.

For those wishing to do so, it is the responsibility of the Participant to take all necessary steps to obtain a funding or grant from a third-party body.

Registration will be definitely validated upon receipt of payment or financing confirmation by a third-party body, **within 15 days** after the participation has been confirmed by the organizers.

5.1 Tuition fees borne by the Participant

After validation of the application by Series Mania Institute, the payment will be due, within 15 days after validation has been confirmed, by bank transfer to the account of SERIES MANIA according to the bank details transmitted for this purpose, in accordance with the payment instructions sent along with the contract and the invoice. This registration can be revoked at any time without justification, as long as the enrolment is not definitive.

Registration will only be confirmed and definitive once payment has been received for the full tuition fee.

5.2 Tuition fees covered by a third-party body

In the event of coverage of the tuition fees by a third-party body, the Participant must contact the organizers, so that a place can be reserved. The financing confirmation will have to be provided within



15 days after validation has been confirmed. This registration can be revoked at any time without justification, as long as the enrolment is not definitive.

Please note that the registration will be confirmed by e-mail to the contact details provided. It is the responsibility of the Participant to ensure that this confirmation e-mail has been received, or to contact the organizers of the program if not.

Registration is only definitive upon receipt of a commitment of funding from the third-party body.

As soon as the participant receives the financial details from the third-party body, it is their responsibility to inform the organizers of the program, so that registration can be validated.

6. Withdrawal, Early termination, Drop out, Cancellation

After registration, the Participant signs an agreement of participation. Within 10 days of signing this agreement, the Participant may withdraw by registered letter with acknowledgement of receipt. The Training Organization will reimburse the full amount of any Training fees already paid to The Training Organization.

Until seven (7) days before the start of the training, 30% of the total amount of the Training fees will be withheld as compensation.

Depending on the number of registered participants, the Training Organization reserves the right to cancel the Training, 2 weeks before the course start date. In this case, the Training Organization will reimburse the full amount of any Training fees already paid to The Training Organization, without financial compensation.

7. Public health context

As the pandemic has had an impact on the timetable and nature of the Series Mania Institute programs, the organizers undertake to inform participants of any changes to the process described in these rules. The workshop organizers reserve the right to suspend, cancel or modify the activities offered to participants. The organizers undertake to inform participants of any changes to the workshop timetable and/or activities. Similarly, participants facing personal or professional problems linked to the health context are required to contact the organizers immediately to inform them.

8. Obligation of means

The program complies with an educational policy drawn up by Series Mania Institute. The organizers undertake to use all the means at his disposal to guarantee the success and transmission of the educational objectives presented.

9. Ownership of the training program

The workshop and its content are the property of Series Mania Institute.



10. Confidentiality and communication

All documents and information supplied through the registration process are strictly confidential and will not be published for any reason.

A list of the participants may be used for communication purposes and published online and in the press.

The organizers undertake, for the duration of the workshop and after, without any time limit, to maintain the utmost confidentiality regarding the information brought to its attention about the participants' series projects.
